

## A. Sekuriteitsaktiwiteite

Gedurende die maand het die JSRA Sekuriteitsbeamptes die volgende suksesse behaal:

‘n Klagte van ‘n vermoedelik gesteelde voertuig is op die Stellenbosch Reaksiegroep gerapporteer. Die voertuig is na bewering op die Helshoogtepad opgemerk, rigting Stellenbosch. Die JSRA Patrollievoertuie en ander Sekuriteitsvennote het aan die SAPD en Wetstoepassing bystand verleen. Die voertuig is afgetrek en SAPD het beheer oor die toneel geneem.

Die Siti Interim SRA Voertuig het bystand gevra m.b.t. ‘n verdagte persoon wat opgemerk is met moontlik gesteelde eiendom. Een JSRA voertuig het bystand verleen en ‘n verdagte met ‘n vermoedelik gesteelde grassnyer is aangekeer. Wetstoepassing het ook bystand verleen. Die verdagte is deur Wetstoepassing na die SAPD geneem, waarna die verdagte gearresteer is vir die besit van vermoedelik gesteelde eiendom.

Die JSRA Beheerkamer het die JSRA voertuie ingelig oor ‘n LPR Alert wat deurgekom het m.b.t. ‘n vermoedelik gesteelde voertuig. Die SAPD is gekontak. Die JSRA Beheerkamer het die voertuig gemonitor terwyl die voertuig gery het. Die voertuig is afgetrek en die verdagte/s en voertuig is aan die SAPD oorhandig.

Daar is ‘n klagte op die Middedorp-groep deurgegee van ‘n huisbraak aangrensend aan die JSRA area. Die JSRA voertuig en Siti Interim SRA voertuig het bystand verleen. Een van die moontlike verdagtes is deur die JSRA voertuig opgemerk en aangekeer. Die verdagte is aan die SAPD oorhandig. Die volgende dag is nog een van die verdagtes opgemerk en ook aangekeer en oorhandig aan die SAPD.

Die JSRA Beheerkamer het ‘n verdagte in die Koloniesland rivierarea opgemerk. Die JSRA Voertuie is onmiddellik uitgestuur, waarna ‘n verdagte gevind is wat besig was om blomme te steel van een van die aangrensende wonings. Die eienaar van die woning het ‘n saak geopen en die verdagte is aan die SAPD oorhandig.

Die Siti Interim SRA voertuig het ‘n verdagte voertuig en verdagtes opgemerk wat vermoedelik besig was met OTM ‘Scamming’. Die voertuig is deur die Siti Interim SRA voertuig gevolg en bystand is verleen deur die aangrensende JSRA voertuig om die persoon te voet aan te keer. Ongelukkig is die verdagte/s in die voertuig verloor. Die verdagte wat te voet was is gevind en aan die SAPD oorhandig.

## A. Security Activities

During the month the Security Officials achieved the following successes:

A complaint of a possible stolen vehicle was received on the Stellenbosch Reaction Group. The vehicle was observed on the Helshoogte Road, direction Stellenbosch. The JSRA patrol vehicles and other security partners rendered support to the SAPS and Law Enforcement. The vehicle was stopped and the SAPS took over control of the scene.

The Siti Interim SRA Vehicle requested support with regard to a suspect person with possible stolen property. One JSRA vehicle rendered support and a suspect with a possible stolen lawn-mower was arrested. Law Enforcement also rendered support. Law Enforcement took the suspect to the SAPS. The suspect was arrested by SAPS for possession of possible stolen property.

The JSRA Control Room informed the JSRA vehicles of a LPR Alert that came through concerning a possible stolen vehicle. The SAPS was informed. The JSRA Control Room monitored the vehicle on the cameras and inform the JSRA vehicles of its movement. The suspected stolen vehicle was stopped and the suspect/s and vehicle were handed over to the SAPS.

A complaint was received on the WhatsApp group of the CBD, concerning a house-breaking at a location bordering the JSRA area. The JSRA vehicle and the Siti Interim SRA vehicle rendered support. One of the possible suspects was observed by the JSRA vehicle and was arrested. The suspect was handed over to the SAPS.

The next day one of the other suspects was observed and arrested and also handed over to the SAPS.

The JSRA Control Room became aware of a suspect in the Koloniesland River area. The JSRA vehicles were immediately send out to the complaint. They found a suspect who was busy stealing flowers from one of the neighbouring houses. The owner of the property opened a case and the suspect was handed over to the SAPS.

The Siti Interim SRA vehicle observed a suspect vehicle and suspects who were possibly involved with ATM Scamming. The vehicle was followed by the Siti Interim SRA Vehicle and support was rendered by the neighbouring JSRA vehicle who found the suspects on foot. Unfortunately the suspects in the vehicle could not be traced. The suspect on foot was handed over to the SAPS.

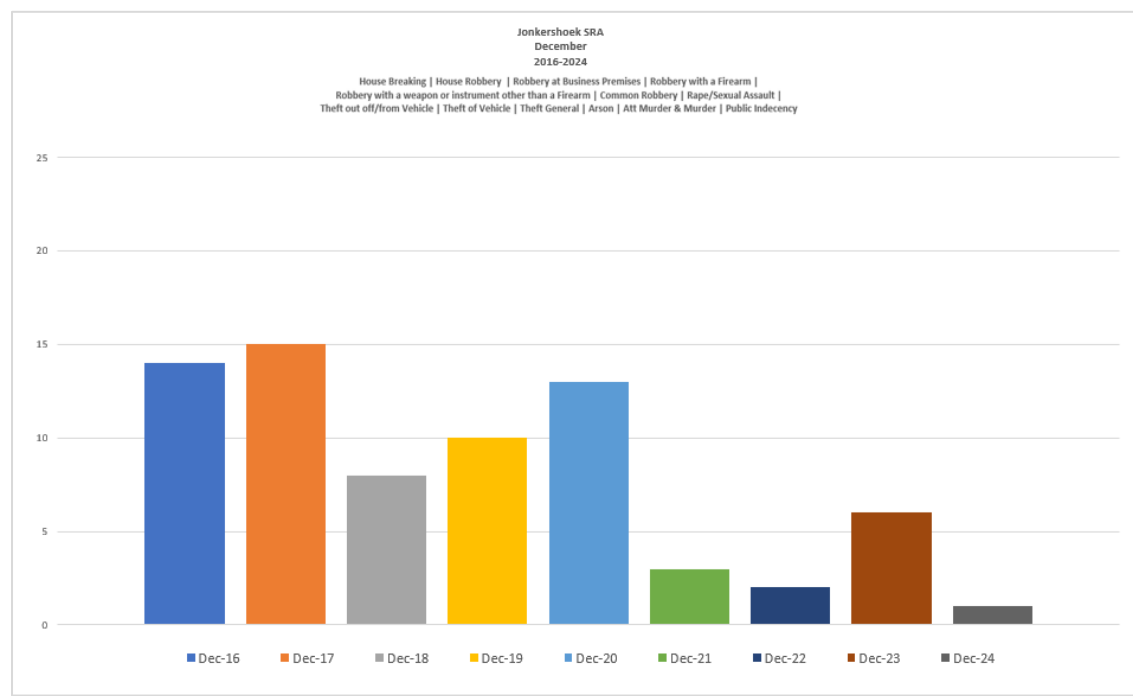
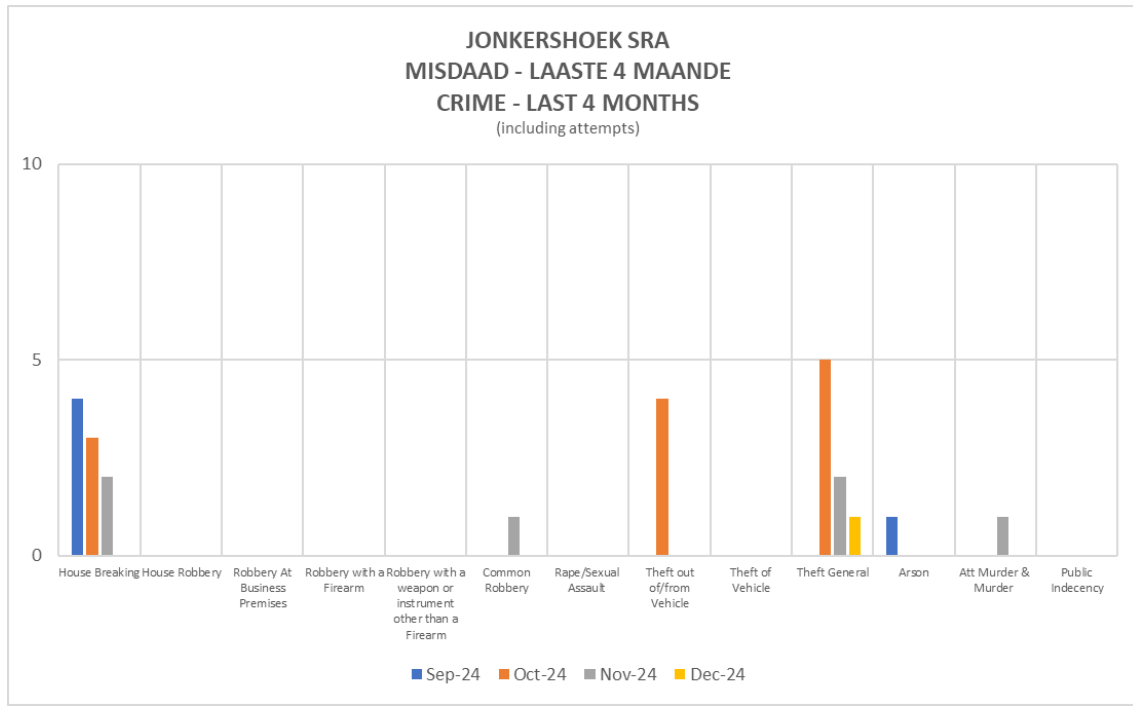
## General security hints:

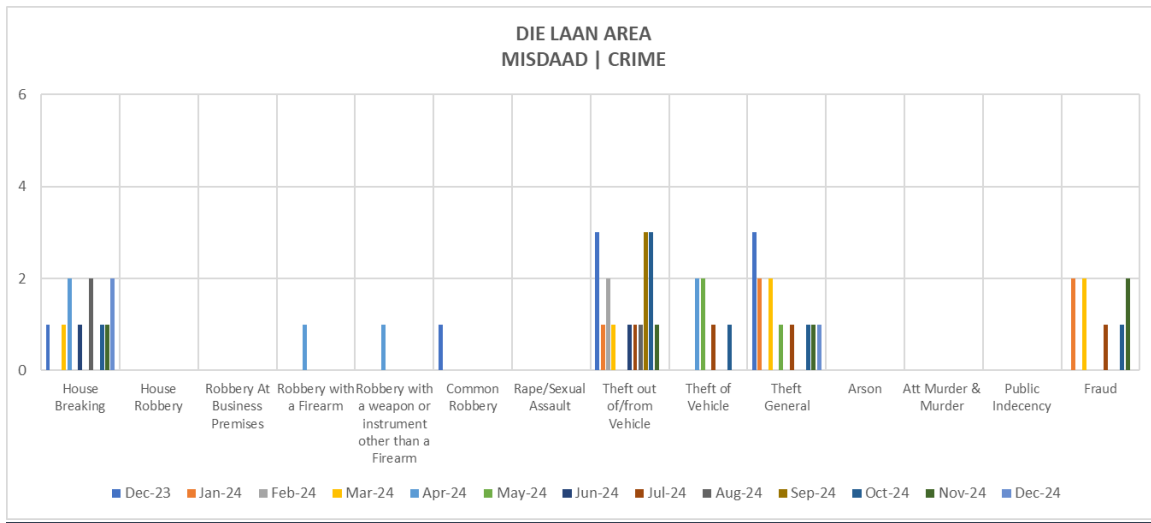
